Provisional Affiliation to run M.Ed. two years course from the session 2016-17 at Laxmi College of Education Vilage Rathiwas (Jat) P.O. Sidhrawali, Distt. Gurgaon Dear Sir

Kindly refer to your proposal to run M.Ed. two years course received vide letter No. LCER/577/2016 dated 17.08.2016 and No.LCER/583/2016 dated 07.09.2016 on the above noted subject.

I am desired to inform you that the Inspection Committee which inspected your college on 17.08.2016 to verify the availability of requisite infrastructural facilities to consider the matter for grant of provisional affiliation of one unit of 50 seats in M.Ed. two years course. On the basis of the recommendations of the Inspection Committee and on the basis of the recognition granted by the NCTE vide letter No.NRC/NCTE/Recognition/2016/147986-93 May 2016 to run the said course, the Vice-Chancellor has been pleased to grant provisional affiliation to run the above said course under section 11(7) of the CRSU Act, subject to consideration and approval of the Academic Council/Executive Council from the session 2016-17.

This provisional affiliation has been granted with the stipulation that your college shall make full compliance of the observations/shortcomings pointed out in the inspection report (Copy Enclosed) within three months including in position the teaching and non-teaching staff, in accordance with the prescribed qualifications, norms and procedure as pointed out in the recognition letter of the NCTE. The college should submit an affidavit on Non-Judicial Stamp Paper of Rs. 10 to the effect that lecturers and Principal (All Eligible) are working in the College well before the commencement of the Academic session along with actual joining of the teachers. Your College is required to get necessary approval from the University with regard to appointment of teaching faculty including Principal with in a period of one month. In case your college is found deficient of infrastructural facilities/teaching faculty, your college will be liable for penalties and other action under the rules. The Compliance of the shortcomings/deficiencies

in this regard may be sent to the University for Necessary Verification within the stipulated period.

The above provisional affiliation is further subject to the following mandatory conditions:-

- I. The College shall constitute Governing Body as per NCTE/University norms.
- II. The Admissions will not exceed beyond the sanctioned intake

The teaching and other staff shall be appointed through properly constituted Selection Committee CPF scheme must be introduced. Service Rules for teaching/non-teaching staff framed by the State Govt./University shall be followed strictly.

- III. The faculty shall be appointed as per NCTE/University norms in the pay-scales prescribed by it from time to time.
- IV. The fee structure prescribed by the State Govt./University shall be strictly followed.
- V. All academic-physical and other infrastructural facilities shall be continued to be provided/upgraded by the college as prescribed by the NCTE/University from time to time.
- The College shall furnish requisite documents and reports as called for by the University from time to time in order to ensure proper maintenance of the infrastructural facilities and academic standards.
- The information furnished in respect of the above course shall be factual and correct. In the event of any information found to be false, misleading or suppressed the provisional affiliation shall be withdrawn by the University without any notice.
- In the event of non-compliance of the University Act, Statutes, Ordinances, Rules, Regulations and any other instructions/guidelines issued from time to time, the Universit shall be free to withdraw the provisional affiliation and all liabilities arising out of such a withdrawn would society lie on the concerned society/College.
- The College shall follow the mode of selection of candidates for admission as approved by the State Govt./University.
- The College shall provide all academic and infrastructural facilities including class-room hostels, library, laboratories, workshops, play-grounds and other amenities required for the smooth conduct of its affairs as per University norms.
- Building: The entire building of the college will be at the disposal of the Controller of Examinations for the purpose of conduct of examinations as and when, the Centre of Examination (for theory and practical both) is created it will be obligatory for the Principal to provide necessary infrastructure for smooth conduct of examination.
- Examination Centre: Creation of an Examination Centre in the college will be at the discretion of the controller of Examinations. The center of examinations for the students studying in the college can be shifted to any other college. In such a situation, it will be the responsibility of the institution to make arrangements for transporting the students to

the Centre of Examinations without any extra charges from the students. Similarly, the University can also shift the students of other colleges/institutes to the college/institution

under reference for which necessary infrastructure will have to be provided by the Principal concerned.

- XII Staff: For the purpose of conduct of examinations, the services of entire teaching and non-teaching staff will be at the disposal of the Controller of Examinations, The examination duties can be assigned to any member of teaching and non-teaching staff which will have to be complied with, in the interest of smooth conduct of examinations.
- XIII Strong Room: There will be a Strong Room in the college at the prime location-adjacent to the office of the Principal to keep the confidential material of the University as and when required. The Strong Room will essentially have double lock system.

Therefore you are directed to complete the above requirements/shortcomings/conditions within a period of three months and send compliance report of the same to this office so that necessary verification is made by the University within the given stipulated period through the same inspection committee. In case of non-compliance of above conditional/requirements within the mode/allowed and your college shall also not be allowed the continuation in conditional provisional affiliation for the next session and the provisional affiliation will be withdrawn..
